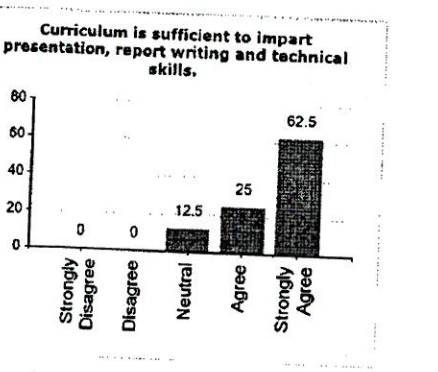
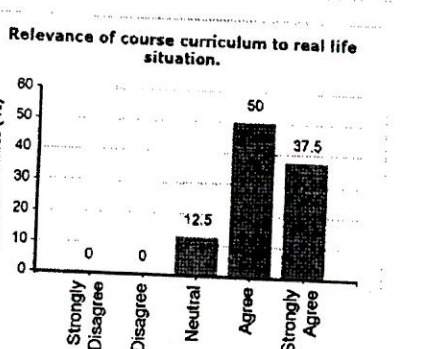
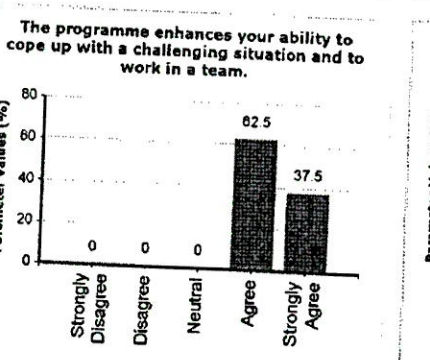
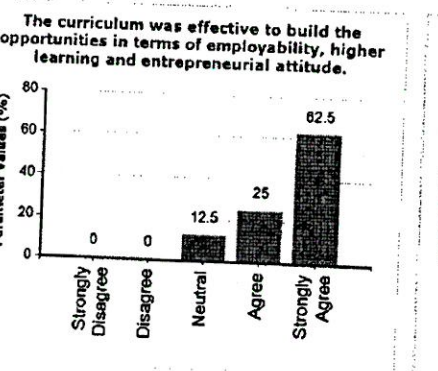
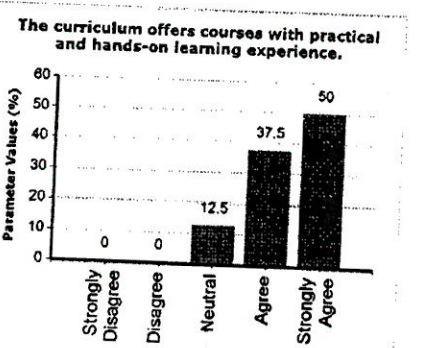
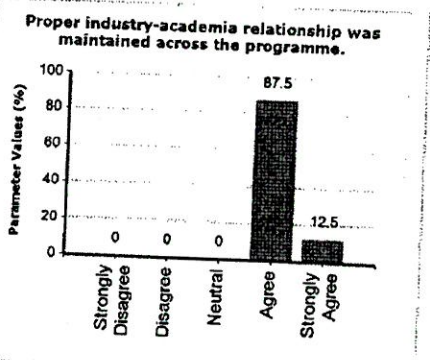
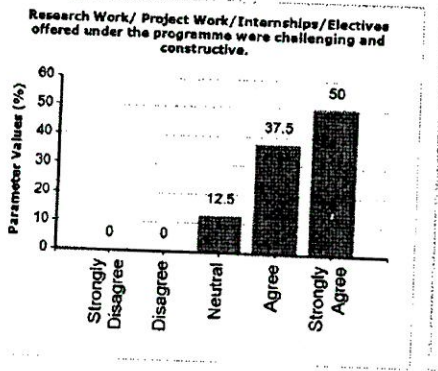
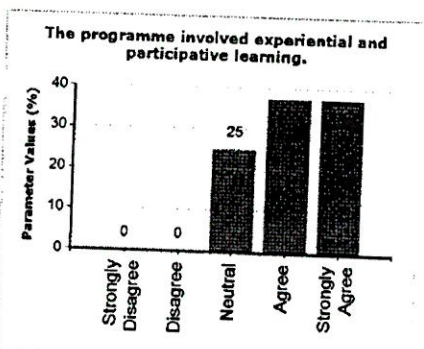
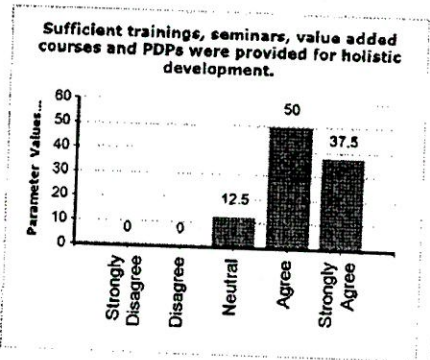
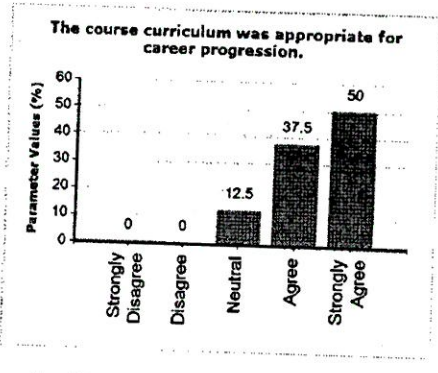
Faculty Feedback Analysis
