General Guidelines of the NEP Cell:

- (i) The Cell shall meet at least once in a semester. However, as per exigencies of the work, the meeting of the Cell may be more as per the prior approval of the Chairperson.
- (ii) One third of the members will form the quorum. Once the meeting is adjourned for want of quorum, the meeting may be reconvened after one hour. The members present will form the quorum.
- (iii) The decision will be as per the majority, in case of equality of vote, the Chairperson will have the casting vote.
- (iv) The agenda of the meeting shall be circulated amongst the members at least 24 hours in advance before the meeting is held.

(v) The Chairperson shall have the power to co-opt or invite any number of persons as Co-opted or Special Invitee members as per the requirement. Such members may participate in the proceedings of the Cell but shall not have the power to vote.

Aims & Objectives of the NEP Cell

The main objectives of the Cell is to translate the vision of NEP 2020 in reality into a time phased manner such as:

- (i) To frame rules and regulations for implementing the Academic Bank of Credits to promote flexibility and facilitation of student's mobility.
- (ii) To frame guidelines on Multiple Entry and Exit in the academic programmes of the University.
- (iii) To frame guidelines for Internship/Apprenticeship embedded degree programmes as part of the curriculum of general degree programme.
- (iv) To frame guidelines on the Credit Framework for online courses through SWAYAM 2021 for recognition and integration of credits-increasing the limits from 20-40%.
- (v) To frame guidelines of internationalization of Higher Education.
- (vi) To frame guidelines for the establishment of an office for International Affairs one stop contacts for foreign students.
- (vii) To frame guidelines for Alumni, connect as University level.
- (viii) To frame any other rules and regulations aimed to improve accessibility, equity, quality, affordability and accountability of the University in a time bound manner.
- (ix) To frame rules and guidelines for offering multidisciplinary programmes and intradisciplinary research.
- (x) To implement the guidelines of the UGC issued from time to time for the orientation of the newly recruited faculty members and inculcation of human values and professional ethics in teaching faculty as well as in students.
- (xi) To make guidelines for eco-friendly and sustainable campus of the University.
- (xii) To frame rules on any other issues which this Cell suo-moto thinks is necessary for the gradual implementation of NEP 2020 and for the overall development of the University through research and innovation.
